

## Action Taken on Feedback of Guardians (2021-22)

### WOMEN'S COLLEGE, TINSUKIA

A Feedback Analysis Report of the session 2021-22 has been prepared on the basis of the responses received from the Guardians of Students of the college. As per findings of the feedback, actions in the requisite areas have been taken as given below.

#### 1. ACADEMIC AND MONITORING

Sl. No.	Findings	Action Taken
1	93.4% (94% in previous year) Guardians are satisfied with the Academic Performance of their Daughter.	Continuous efforts are on to maintain the standard.
2	52.1% (51.5% in previous year) guardians <i>regularly</i> and 45.5% (43% in previous year) <i>randomly</i> monitor their ward's Academic Performances.	Guardians/ parents are made aware of their responsibilities by organizing periodic meetings with them.
3	50.4% (58.5% in 2020-21 & 65.7% in 2019-20) guardians opine that they don't have contact with teachers concern to their ward's subjects.	Guardians/ parents are made aware of their role in making the teaching learning successful. Phone numbers of the mentors are provided to the guardians (so that they can easily contact them) and also uploaded in the college website.
4	93.4% (90.5% in previous year) Guardians monitor the attendance of their ward to figure out whether she has attended her classes regularly or not.	Guardians/ parents are made aware of their responsibilities towards their wards.

#### 2. CONTRIBUTION AND INVOLVEMENT

Sl. No.	Findings	Action Taken
1	27.3% (42% in previous year) guardians opine that they have not attended the guardian meetings organised by the college.	Guardians/ parents are made aware of their responsibilities in their association (PTA).
2	76.9% guardians have not made any contribution for overall development of the college.	Attempts have been made to persuade the guardians to contribute in developmental works of the college. Over the years some guardians have contributed their bits.
