ARTICLE 3

LOCATION OF ACTIVITIES

ARTICLE 5

SETTLEMENT OF DISPUTE

ARTICLE 6

AMENDMENT

1. This MoU may be amended or revised at any time by mutual written consent of both the parties.
2. Such amendment or revision shall come into force on the date as may be determined by both the parties.


ARTICLE 7

ENTRY INTO FORCE, DURATION AND TERMINATION


1. This MoU shall enter into force on the date of signing.
