ACKNOWLEDGING that

1. The Department of English, Women's College, Tinsukia-786125 hereinafter known as WCTTSK, a premier Girls' educational institution of higher education in Assam, having its address at Tinsukia, Assam 786125
2. Padmanath Gohain Baruah Govt. Model College, Kakopathar-786152, hereinafter known as PNGBGMC, a co-educational institution of higher education in Assam, having its address at Kakopathar, Assam 786152

DESIRING to cooperate in academic and extra-curricular activities between students and teachers of the two institutions.

PURSUANT TO the prevailing laws and regulations, policies and procedures of both the institutions HAVE REACHED the following understanding:

ARTICLE 1  
**OBJECTIVE OF COOPERATION**

The objective of this Memorandum of Understanding (MoU) is to cooperate in educational endeavours in areas of mutual interest.

ARTICLE 2  
**SCOPE OF THE UNDERSTANDING**

The Parties agree to cooperate on the following points:

1. Faculty and student exchanges on academic and extra-curricular activities between the English department.
2. Skill-based/Add on courses that are mutually agreed upon by both the parties.

ARTICLE 3  
**LOCATIONS OF ACTIVITIES**

1. The Parties agree to implement the activities stated in Article 2 at WCTTSK and PNGBGMC in blended mode (both online and offline.)
2. Any changes of the location of the programs shall be mutually agreed upon by both the Parties.

ARTICLE 4  
**FINANCIAL ARRANGEMENT**

1. Any cooperation under this MoU is subject to the availability of funds, funding sources and approval by relevant authorities.
2. Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

ARTICLE 5  
**SETTLEMENT OF DISPUTE**


Any dispute concerning the interpretation and/or application of this MoU shall be settled amicably through consultation or negotiation between both the Parties.

ARTICLE 6  
**AMENDMENT**

1. This MoU may be amended or revised at any time by mutual written consent of both the Parties.
2. Such amendment or revision shall come into force on the date as may be determined by both the Parties.

ARTICLE 7  
**ENTRY INTO FORCE, DURATION AD TERMINATION**


1. This MoU shall enter into force on the date of signing.
2. This MoU shall remain in force for a period of three years and may be extended by mutual written consent of both the parties.



3. Either Party may terminate this MoU at any time by giving prior written notification to the other Party on its intention to terminate this MoU.
4. The termination of this MoU shall not affect the completion of any projects and programs in progress.
