



## MEMORANDUM OF UNDERSTANDING



This Memorandum of Understanding is made on the 12<sup>th</sup> day of December, 2022

between

**Women's College, Tinsukia**, an affiliated college under the Dibrugarh University, located in the district of Tinsukia, Assam, hereinafter referred as the **Party - 1** and to be represented by its Principal.

and

The **Sadiya College, Chapakhowa**, hereinafter referred as the **Party - 2**, represented by its Principal or any of its officers authorised by the Principal, Sadiya College

### 1. Objective:

**Women's College, Tinsukia**, since its inception in 1966 has been rendering its unstinted services towards women empowerment in this region. Students from Assam, Arunachal Pradesh and Nagaland have been availing its quality teaching learning since last six decades.

**Sadiya College** is reputed provincialized college of the Sadiya subdivision of the Tinsukia district, known for its green and environment friendly campus, young and talented faculties and sports & cultural activities.

It is believed that a collaborative venture, in the form of a MoU between the two parties will be beneficial to both on many counts – especially in the fields of sharing of library resources, student-exchange programs, cultural exchange programs, faculty exchange programs etc.

### 2. Scopes:

This MoU is a statement of understanding and is not intended to create binding or legal obligations on either party. This MoU will enable the two signing parties to:

- Exchange Academic resources/ faculties (experts) between the two parties (as guest lecturers/ Visiting Professors).
- Both parties, as per their conveniences, will organize student exchange programs for Academic and Cultural Exchange.
- Party-1 will open its Add-on courses to the students/ staff of Party - 2.
- Party-2 will be allowed excess to the rich Library resources of party-1.

### 3. Funding:

Normally programs will be conducted without any financial liabilities. However both parties will bear the necessary expenses in the event of any such requirements.

#### 4. Duration

This MOU is at will and may be modified by mutual consent of authorized officials from the two Institutions (Parties). This MoU shall become effective upon signature by the authorized officials from the two parties and will remain in effect until modified or terminated by any one of the partners by mutual consent. In the absence of mutual agreement by the authorized officials from two parties this MoU shall end at the completion of two years from the date of signing of the same.
