With reference to the subject cited above, I would like to inform you that, Applications for Pre & Post Matric Scholarships to students of SC & OBC community of Assam is live on National Scholarship Portal - NSP (<https://scholarships.gov.in/>).

In this regard, the students may take help of Common Service Centres (CSC) for One Time Registration (OTR), Bio-Authentication and filling of applications form in NSP for which a nominal fixed service charge of Rs.30/- (inclusive of all taxes) per candidate for the entire above activity will be charged by CSC only after successful submission of the application form on NSP. The students will not pay anymore charges for the entire exercise and may collect the application acknowledgement number generated from NSP and a receipt of the amount paid to CSC.

I would therefore request you to instruct the INO & HoI under your jurisdiction to inform the students to apply for scholarship with OTR and Bio-Authentication with the help of CSC to timely submit application with ease.
