1. Educational Qualifications:-

- i) The minimum educational qualification of the candidates shall be Graduate/Degree examination passed in any discipline from a University recognized as such by the State/Central Government or a Degree equivalent thereof and recognized by the State/Central Government.
- ii) The Candidates must have good working knowledge and skill in Computer, specially Word Processor, Spreadsheet, Presentation Graphics, Concept of Database, Internet, E-mail etc.
- iii) The Candidate must possess a minimum 6 months Diploma Certificate in Computer Application/Knowledge from Government recognized institute.
- 2. Nationality:- Candidate must be a Citizen of India.
- 3. <u>Age:</u> Candidate must not be less than 18 years and not more than 40 years of age as on 01/01/2021. The Upper Age limit is relaxable for candidates belonging to SC/ST categories upto 45 years: for the candidates belonging to OBC/MOBC categories upto 43 years, for candidates belonging to ex-Servicemen category upto 42 years and for candidates belonging to persons with disabilities upto 50 years as per Govt. OM No. ABP.06/2016/51, Dated: 02/09/2020 issued by the Government of Assam in Personnel (B) Department.
